President Heine Welcomes U.S. Ambassador Stewart

President Dr. Hilda C. Heine accepted the diplomatic credentials of Ambassador Karen B. Stewart, the newly appointed Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of the Marshall Islands. The presentation of credential ceremony was held at the Cabinet conference room on Monday, 25 July 2016.

President Heine congratulated Ambassador Stewart and reiterated the RMI Government's commitment to the special and unique relationship between the two countries under the Compact. She acknowledged the RMI Government's appreciation for the invitation of

a staff working level meeting in August to discuss the 10 Year Review Report of the Compact, as Amended.

President Heine conveyed concern regarding the possible discontinuation of the "Ri-Katak" Program at the United States Army Garrison Kwajalein Atoll and the Government's disappointment and view on the recent U.S. Department of State's Trafficking in Persons Report.

"We have many outstanding matters to resolve and I am confident that over the course of the next few

weeks we can dialogue on these with a view to finding ways forward," stated President Heine.

President Heine expressed, on behalf of the people and Government of the RMI, deepest condolences for the passing of Hawaii Congressman Mark Takai. Concluding her remarks, President Heine said she looks forward to working closely with the Ambassador to engage further on matters of common interests between the two countries.

Ambassador Stewart reciprocated by thanking President Heine for the warm welcome and conveyed desire to build on the strong record of friendship from her predecessor, former Ambassador Thomas Armbruster.

Ambassador Stewart was nominated by U.S. President Barack Obama to be U.S. Ambassador to the RMI in November 2015.

Prior to her new post, Ambassador Stewart served as Political Advisor to the Vice Chairman of the Joint Chiefs of Staff and to the Supreme Allied Commander Transformation since 2013. She has also served as U.S. Ambassador to Laos (2010–2013) and Belarus (2006–2008).

Agenda 2020: A Framework for Progress

Immediately after assuming office in February this year, President Heine's Administration undertook a stock-take of major challenges and priority institutional reforms in relation to Government Ministries and agencies respective functions and roles. The process is critical towards strengthening efficiency and effectiveness of Government and its services to the people.

Following two Cabinet Retreats, *Agenda 2020: A Framework for Progress* (Agenda 2020) was developed to serve as an outline to help the Government focus its attention on identified urgent and strategic priorities and to ensure Government services and delivery mechanisms are efficient and on target. There are ten challenges and ten priority Government reforms identified in Agenda 2020.

The RMI's National Strategic Plan (NSP) is inevitably linked to Agenda 2020 and the Sustainable Development Goals (SDGs). Agenda 2020 was supported by the Marshall Islands Mayors Association and the Marshall Islands Chamber of Commerce.

Agenda 2020 identifies ten challenges and ten priority Government reforms

Challenges

- 1. Growing the Economy
- 2. Preparing for the post-2023 Compact transition
- 3. Improving Majuro Hospital and basic health services
- 4. Supporting education, youth, and vulnerable groups
- 5. Adapting to climate change and reducing disaster risks
- 6. Strengthening water, energy, and food security
- 7. Improving the quality of life on Ebeye and other Kwajalein communities
- 8. Improving the welfare of outer islands communities
- Tackling consumer debt and strengthening consumer protection
- Strengthening laws, justice, and public safety

The 16th RMI Executive Leadership Joint Communiqué, signed on 18 July 2016, acknowledges and supports Agenda 2020.

President Heine and members of the Cabinet held discussions with the executive members of the Chamber of Commerce on 28 July 2016, who reiterated the importance of increasing jobs, current and potential retirees in relation to MISSA, and the need to increase local fisheries (including coastal fisheries), among others. Also discussed was local investment promotion which entails minor law amendments, such as MISSA requirements to invest overseas. All in all, the Chamber of Commerce supported Agenda 2020, and looked forward with working with President Heine's Administration in the coming years.

Localization of the Sustainable Development Goals

The RMI Government, in partnership with the UN and the Pacific Islands Forum Secretariat, held a Sustainable Development Goals (SDGs) sensitization workshop at the ICC last week from 28-29 July. The workshop raised awareness on the SDGs and held discussions on localizing and aligning the goals to the RMI's national development and priorities. Incorporated into the discussions was Cabinet's recent Agenda 2020 Framework that is in the process of being formalized.

President Dr. Hilda C. Heine emphasized on ensuring that the SDGs are well-aligned with RMI's growth and development aspirations while encouraging active participation, partnerships, and collective efforts of stakeholders. In addition, President Heine touched on the need to align relevant policies, strengthen regulatory framework where necessary in order to better align private sector incentives with public goals.

She noted key bilateral structures, in particular, the RMI-US Compact that can explore strategic approaches to addressing the SDGs in partnership. "The Government is committed to the Sustainable Development Goals and looks forward to forging the necessary partnerships needed to realize and achieve the goals," said President Heine.

Minister-in-Assistance Mattlan Zackhras said an "island-tailored" strategy of national ownership - and stakeholder partnership- is needed.

He underscored the challenges for policy integration, implementation, and data-driven monitoring, particularly for a small, capacity-challenged nation like the RMI. Data capacity will be a particular challenge where the SDGs could include a heavy data burden, however, the RMI should explore very practical approaches at the national level including instances where existing pathways can be utilized, he said.

"...the RMI's national SDG strategy must be a benefit, not a burden," stated Minister Zackhras.

UN Resident Coordinator for the Pacific, Ms. Osnat Lubrani, congratulated the Government of the RMI on its leadership and foresight for getting onboard the SDG train so soon in 2016–the first year of implementation of the 2030 SDG Agenda.

The expected outcome of the workshop is the development of a roadmap that will provide a holistic and clear direction in meeting national development plan and aspirations whilst linking in the SDGs. One of the key outcomes of the workshop was identifying First Gentleman Thomas Kijiner Jr. as the national champion for the SDGs.

Philippines Donates \$50K for Disaster Relief Efforts



Heine conveyed gratitude for the generous donation and reiterated the RMI's commitment to further strengthening the relationship between the RMI and the Philippines.

ROC (Taiwan) Hands Over Disaster Relief Goods

During a hand-over ceremony organized by the Ministry of Foreign Affairs last week Wednesday, ROC (Taiwan) Charge d'Affaires Robert Lo officially handed over a cargo container of charity items to President Dr. Hilda C. Heine, who received on behalf of the people and Government of the RMI. The items are donations from SimplyHelp, a non-profit charity organization based in Los Angeles, California, dedicated to relieving poverty by providing emergency disaster relief assistance.

Foreign Minister John M. Silk conveyed appreciation to ROC (Taiwan) Ambassador Winston Chen, Charge d'Affaires Robert Lo, and the ROC (Taiwan) Embassy for arranging the delivery of charity items with SimplyHelp, following the RMI Government's call for assistance from partners and organizations toward the Government's disaster drought relief efforts. Minister Silk said the donation is a welcome gift to the people of the RMI, particularly to the people living in the outer islands that are suffering from the drought.

Charge d'Affaires Lo announced that a container shipment of quality rice is on its way to the RMI, slated to arrive on August 10th. "This will not be the last one...we expect another handover ceremony," said Charge d'Affaires Lo. He thanked the RMI Government for the continued support of ROC (Taiwan)'s meaningful participation at the UNGA and other UN specialized agencies and mechanisms, such as, the ICAO and UNFCCC.
